ASA Auto Slack	Severe Duty	Use in off-road refuse, & heavy haul applications.	2 years from date of manu- facture or 100,000 miles
ASA Auto Slack	City Transit	For use in intracity transit applications.	1 years from date of manu- facture or 100,000 miles
ASA Auto Slack	Intercity Transit	For use in intercity transit applications.	2 years from date of manu- facture or 200,000 miles

All claims must be made within the warranty period. The TSE slack adjuster must be returned for examination, together with detail of the fault found, distance in service and application.
